# Road Transport (Change of ownership of Vehicles) Regulations

### 1. Citation

These regulations may be cited as the Road Transport (Change of ownership of Vehicles) Regulations.

#### 2. Transfer of vehicles

On the change of ownership of a vehicle the transferor and transferee shall both sign a form supplied by the licensing authority notifying the change of ownership to such authority.

### 3. Registration of transfer of motor vehicles

In the case of motor vehicles such change of ownership shall be registered in a special register kept by the licensing authority for the purpose.

### 4. Fee payable on transfer of motor vehicles

On the change of ownership of a motor vehicle a fee of Rupees 100 shall be paid by the transferee to the licensing authority.

### 5. Fee to be paid before registration of transfer

The licensing authority shall not register the change of ownership of a motor vehicle if the fee in respect thereof has not been paid.

### 6. Transfer to operate when fee paid and registration effected

When a change of ownership has been notified to the licensing authority in accordance with regulation 2 such notification shall not operate the transfer of the motor vehicle to the transferee unless the fee has been paid and the change of ownership registered.
