In exercise of the powers conferred by section 137(2)(d) of the Animal and Plant Biosecurity Act, 2014, the Minister of Natural Resources, on the advice of the Seychelles Agricultural Agency and the National Biosecurity Committee makes the following Regulations—

1. These Regulations may be cited as the Animal and Plant Biosecurity (Fees and Charges) Regulations, 2014. Citation
2. The fees payable in respect of the biosecurity services provided by the Agency in Column 2 of the Schedule shall be as specified in the corresponding entry in column 3 of the Schedule. Fees
3. The fees shall be paid to the Agency at its offices or at such other places designated by the Director for that purpose. Payment of fees
