## Civil Aviation (Search and Rescue) Regulations, 2018

In exercise of the powers conferred by section 3 (1) of the Civil Aviation Act, the Minister of Tourism, Civil Aviation, Port and Marine makes the following Regulations —

These Regulations may be cited as the Civil Aviation (Search and Rescue) Regulations, 2018.

### In these Regulations — 2.

Interpretation

"national search and rescue plan" means a document that describes goals, arrangements and procedures which support the search and rescue services;

"The Seychelles Joint Search and Rescue Coordination Centre" means the centre administered jointly by the Sevchelles Coast Guard, the Seychelles Civil Aviation Authority and the Seychelles Maritime Safety Administration responsible respectively for the civil aeronautical and maritime search and rescue operations in the Seychelles search and rescue region.

"search and rescue co-ordinating committee" means the search and rescue co-ordinating committee established under regulation 6;

"search and rescue services" means the performance of distress monitoring, communication, coordination and search and rescue functions, initial medical assistance or medical evacuation, through the use of public and private resources, including cooperating aircraft, vessels and other craft and installations;

"Seychelles search and rescue region" means an area of defined dimensions, recognised by the International Civil Aviation Organisation and the International Maritime Organisation associated with the Seychelles Joint Rescue Coordination Centre, within which search and rescue services are provided;

"Seychelles Maritime Safety Administration" means the Seychelles Maritime Safety Administration established under the Merchant Shipping Act, 1992 as amended;

"Search and Rescue Unit" means a mobile resource comprising of trained personnel and provided with equipment suitable for the expeditious conduct of search and rescue operations.

Seychelles Joint Search Rescue Coordination Centre

- 3.(1) There is hereby established a centre responsible for aeronautical and maritime search and rescue services to be known as the Seychelles Joint Search and Rescue Coordination Centre.
- (2) The Seychelles Joint Search and Rescue Coordination Centre shall consist of members of the Seychelles Coast Guard and officers of the Seychelles Civil Aviation Authority and the Seychelles Maritime Safety Administration.
- Coordination Centre 121 (1) (2) (3) The Seychelles Joint Search and Rescue
- shall provide search and rescue services to aircraft and vessels in distress within the Seychelles Search and Rescue Region in accordance with the national search and rescue plan referred to in regulation 6;

Interpretation

Seychelles Joint Search Rescue Coordination Centre

- 3.(1) There is hereby established a centre responsible for aeronautical and maritime search and rescue services to be known as the Seychelles Joint Search and Rescue Coordination Centre.
- (2) The Seychelles Joint Search and Rescue Coordination Centre shall consist of members of the Seychelles Coast Guard and officers of the Seychelles Civil Aviation Authority and the Seychelles Maritime Safety Administration.
- (3) The Seychelles Joint Search and Rescue Coordination Centre—
  - (a) shall provide search and rescue services to aircraft and vessels in distress within the Seychelles Search and Rescue Region in accordance with the national search and rescue plan referred to in regulation 6;
