## SEYCHELLES: New National Phase Patent Application in the name of Fourth Military Medical based on PCT/CN2017/082713 filed 2nd May 2017

#### Amendment of Claims and Correction of Sequence Listing

In the amended claims, all 6 CDRs of the antibodies in the claims have been limited and unpatentable method of treatment claims have been cancelled. All amendments are fully supported by the specification and limit the extent of the protection conferred.

To amend some formality defects and an obvious mistake in the sequence listing submitted upon filing the application.

Specifically, the features under identifiers <220> to <223> for the variable symbols "Xaa" in SEQ ID NOs: 13, 14 and 25-27 have been defined; the features under identifier <221> in SEQ ID NOs: 9-15 and 22-32 have been corrected.

SEQ ID NO: 8 has been amended to correct an obvious error. The sequence type of SEQ ID NO: 8 was mistakenly selected as "protein" rather than "DNA". As a result of this error, the

program that generated the sequence listing (Patentin Version 3.5.1) identified each nucleotide in the original sequence (a,t,c,g) as one-letter amino acid code and automatically converted each code into three-letters amino acid code ("a" became "ala", "t" became "thr", "c" became "cys", and "g" became "gly").

It is submitted that the error in SEQ ID NO: 8 is an obvious error which would have been readily recognized by those of skills in the art. The present application clearly stated throughout the whole specification that SEQ ID NO: 8 is a nucleotide sequence encoding heavy chain variable region of antibody HP6H8-3 (see in paragraph [0032], [0097], [00108] of the PCT publication W02017186182Al and also in the sequence description section for SEQ ID NO: 8). Also, the original sequence listing at SEQ ID NO: 8 describes at <223> that the sequence is "Nucleic acid sequence of heavy chain variable region (VH) of humanized antibody HP6H8-3". It is therefore not only obvious that there is an error in SEQ ID NO: 8, but it is also obvious what the correct nucleic acid sequence should have been by converting the three-letter amino acid code to one-letter nucleotide code.

SEQ ID NO: 6 has also been amended to correct two obvious errors. Firstly, by comparing to the computer readable form of sequence listing we submitted to WIPO, it can be seen clearly that a "C" was accidentally left out at position 60 of SEQ ID NO: 6 as shown in the sequence listing published in end of the specification. Secondly, the sequence description under identifiers <223> should be "Nucleic acid sequence of heavy chain variable region (VH) of humanized antibody HP6H8-2" rather than "Nucleic acid sequence of heavy chain variable region (VH) of humanized antibody HP6H8-1. Support for this amendment can be found in paragraph [0097] of the PCT publication W02017186182A1.

Accordingly, the correction of SEQ ID NO: 6 and 8 introduces no new matter, and should be allowable.

The sequence listing appended in the end of the specification shall be corrected accordingly. To this end, amended description pages 50 to 75, which include the amendments described above.

In conclusion, it is submitted that the content of the corrected sequence listing includes no new matter and does not go beyond the disclosure of the application as filed.


