Application, by petition, to be appointed executor pursuant to section 23(2) of the Curatelle Act 2021 - Applicant has no legal incapacity - Deceased owned immoveable property - This Court grants the application, and accordingly, appoints Noddy Shilo Javoue Nicoire of Foret Noire Mahe, Seychelles executor to the estate of her late father Ken Jean-Joseph Nicoire, who died intestate on the 8<sup>th</sup> December 2008 at Beau Vallon, Mahe, Seychelles.

**ORDER****N BURIAN, MASTER**

[1] This is an application by the petition, by Noddy Shilo Javoue Nicroire of Foret Noire, Mahe, Seychelles (hereinafter referred to as “the Applicant”) for an order of this Court appointing her executrix of the estate of the late Ken Jean-Joseph Nicoire. The Applicant has filed this application by virtue of section 23(2) of the Curatelle Act 2021 (hereinafter ‘the Act’), which application is supported by an affidavit as well as other relevant documents required to be produced as stipulated in section 23(6) of the Act.

[2] On account of the affidavit evidence in support of the application, and the documentary evidence tendered before this Court as exhibits, I am satisfied, that as per his Certificate of Death pertaining to the Civil Status Register No 549 of 2008. C Ken Jean-Joseph Nicoire also known as Joseph Nicoire (hereinafter referred to as “the deceased”) died on the 8<sup>th</sup> day of December 2008 at Beau Vallon, Mahe, Seychelles. The deceased died intestate and his Certificate of Death is tendered as exhibit marked P1.

[3] I am satisfied, that at the time of his death, the deceased person was survived by the following heirs, namely;

- (i) His wife, Cecile Elisa Nicoire;
- (ii) Noddy Shilo Javoue Nicoire, his daughter;
- (iii) Nodia Jeanne-D’Arc Nicoire, his daughter; and
- (iv) Sharon Rita Liza Nicoire, his daughter.

Copies of the certificate of marriage and birth certificates of the deceased’s children are tendered as exhibits and collectively marked P2.

[4] I am also satisfied, that at the time of the death of the deceased person he owned immoveable property, namely, a parcel of land registered as V6215 in Seychelles. A copy of the official search is tendered as exhibit P3.

- [5] I am satisfied, that it is necessary for an executor to be appointed to administer the estate of the deceased person and I am also satisfied, that the Applicant who wishes to be appointed executrix of the estate of the deceased person, is not subject to any legal incapacity, is ready and willing to be so appointed and to perform the duties of an executor as laid down by law, more particularly, under Article 1027 and 1028 of the Civil Code of Seychelles Act 2020.
- [6] I therefore grant the application, and accordingly, I appoint the Applicant Noddy Shilo Javoue Nicoire executrix of the estate of the deceased person Ken Jean-Joseph Nicoire.
- [7] In line with the provisions of section 23(8) (a) and (b) of the Curatelle Act 2021 and upon payment of the prescribed fees to the Registry of the Supreme Court, I hereby direct as follows:
- (i) That a copy of the order of appointment of executor containing the extract is to be sent for registration at the Mortgage and Registration Office; and
  - (ii) That a notice of the said appointment of executor shall be published in the Gazette as per the prescribed form of the Second Schedule of the Act.
