**Road Transport (Parking Fees) (Amendment)
Order, 2013**

In exercise of the powers conferred by section 17 of the Road Transport Act, the Minister of Home Affairs and Transport makes the following Order—

1. This Order may be cited as the Road Transport (Parking Fees) (Amendment) Order, 2013.

Citation

2. The Road Transport (Parking Fees) Order, 1995 are amended —

Amendment of
Cap 206

(a) by repealing in regulation 3 paragraph (1) and substituting therefor the following —

(1)(a) the parking fees shall be paid by parking coupons purchased at places designated in a notice published in a local newspaper by the Road Transport Commissioner.

(b) the Road Transport Commissioner may issue monthly parking coupons in the amount of SCR250.

(b) by repealing schedule 1 and substituting therefor the following —
