

S.I. 85 of 2014**CUSTOMS MANAGEMENT ACT, 2011***(Act 22 of 2011)***Customs Management (Prohibited and Restricted Goods) (Amendment) Regulations, 2014**

In exercise of the powers conferred by section 270 of the Customs Management Act, 2011, the President acting as the Minister of Finance, Trade and Investment hereby makes the following regulations—

1. These regulations may be cited as the Customs Management (Prohibited and Restricted Goods) (Amendment) Regulations, 2014.

2. The Customs Management (Prohibited and Restricted Goods) Regulations, 2014 is hereby amended as follows—

(a) in the First Schedule—

(i) in the entries relating to “CFC gas and equipment dependent on cfc and hydro-chloro carbon (hcfc)—

(A) under column (2), by repealing the figures “2903.3900” and substituting therefor the figures “2903.3910”;

(B) under column (2), by repealing the figures “2903.1300” and substituting therefor the figures “2903.1310”;

(C) under column (3), by repealing the words “the Environment Protection

- (A) by repealing under column (2) the figures "28.10 to 28.53" and substituting therefor the following—

- (B) by inserting before the figures "3808.9911" and entries relating thereto under columns (2) and (3) the following—

(viii) in the entries relating to "Alcoholic beverages" by repealing under column (2) the figures "2208.9099" and substituting therefor the figures "2208.9029";

(ix) by repealing the entries relating to "Vehicle and Chassis/Bodies" and Spark-ignition reciprocating piston engine of kind used for the propulsion of vehicles of chapter 87" and "Compression-ignition internal combustion piston engine (diesel or semi diesel engines) of kind used for the propulsion of vehicles of chapter 87" and substituting therefor the following entries—
