(Act 25 of 2011)

Agency for Social Protection (Maximum Payment for Exceptional Needs) (Amendment) Regulations, 2020

In exercise of the powers conferred by section 34 read with section 22 of the Agency for Social Protection Act, 2011, the Minister responsible for Social Affairs makes the following regulations —

1. These regulations may be cited as the Agency for Social Protection (Maximum Payment for Exceptional Needs) (Amendment) Regulations, 2020.

Citation

2. The Agency for Social Protection (Maximum Payment for Exceptional Needs) Regulations, 2012 are amended as follows —

Amendment of S.I. 52 of 2012

- (a) by repealing in regulation 2 the words "SCR5000" and substituting therefor the words "SCR10000";
- (b) by inserting after regulation 3 the following regulation
 - Conditions for payment under regulation 2 exceeds SCR5000 it shall be subject to the following conditions
 - (a) the amount shall be paid only for payment of rent of the residential building of the applicant;

- (b) the amount shall be paid only once in a year;
- (c) as far as practical the amount shall be paid directly to the owner of the residential building of the applicant.".

1. These regulations may be cited as the Agency for Social Protection (Maximum Payment for Exceptional Needs) (Amendment) Regulations, 2020.

Citation

2. The Agency for Social Protection (Maximum Payment for Exceptional Needs) Regulations, 2012 are amended as follows —

Amendment of S.I. 52 of 2012

- (a) by repealing in regulation 2 the words "SCR5000" and substituting therefor the words "SCR10000";
- (b) by inserting after regulation 3 the following regulation
 - Conditions for payment under regulation 2 exceeds SCR5000 it shall be subject to the following conditions
 - (a) the amount shall be paid only for payment of rent of the residential building of the applicant;
