PUBLIC HEALTH (INFECTIOUS DISEASES) REGULATIONS

Infectious Disease (Prohibition of Public Assemblies) (No. 2) Order, 2020

WHEREAS, the Coronavirus Disease 2019 (COVID-19) has spread across the majority of the countries in the world;

AND, WHEREAS, the Public Health Commissioner published a Notice in the Gazette on 20th March, 2020 declaring a Public Health Emergency in Seychelles and directed all persons to comply with the directions and orders issued by the public health authorities and cooperate with the Public Health Authority in preventing and containing the spread of COVID-19 in Seychelles;

AND, WHEREAS, by a Prohibition Order dated 21st March, 2020 which was published through Seychelles Nation and Department of Health, Seychelles, website on 26th March 2020, and in the Gazette of 23rd March, 2020, the Public Health Commissioner ordered the prohibition of all public assemblies and all indoor public assemblies in the whole of Seychelles;

AND, WHEREAS, the Public Health Commissioner considers it necessary to impose more restrictions on the movement and assembling of people in Seychelles to effectively curb the spread of COVID-19;

NOW, THEREFORE, in exercise of the powers conferred by regulation 8 of the Public Health (Infectious Diseases) Regulations (S.I. 8 of 1960), the Public Health Commissioner hereby makes the following further orders —

1. (a) all retail shops in Seychelles shall be closed between 6.30 o'clock in the evening and 6.30 o'clock in the morning;
- (b) all retail food outlets shall be closed between 8.00 o'clock in the evening and 6.30 o'clock in the morning; and
- (c) the owner, manager, or any person in control, of the trade premises shall comply with the existing directions issued by the Public Health Commissioner in respect of social or physical distancing and hygiene to be observed by the workers and consumers at such trade premises so as to remove the risk of infection or spread of an infectious disease.
2. In furtherance of the promulgation of the Public Health (Infectious Disease) (Amendment) (No.2) Regulations, 2020 (S.I. 58 of 2020), where a prohibition order is in force —
 - (a) no assembly of more than four persons shall be held for any purpose in any building without the permission of the Public Health Commissioner, which permission may be subject to such conditions as are specified in the permit;
 - (b) any group of four or more persons who have assembled spontaneously shall disperse and any member of such group who fails to depart when instructed by a police officer to do so, may be arrested without warrant and is liable, on conviction, to a fine not exceeding SCR20,000 or to imprisonment not exceeding 2 years;
 - (c) no games shall be held and no assembly of more than four persons for any activity or purpose shall be held on any beach without the permission of the Public Health Commissioner.
3. In regards to indoor public assemblies, the prohibition order shall not have the effect of prohibiting assembly exclusively for the purposes of work at the workplace or shopping or consumption at any trade premises or making use of any service including medical assistance, provided that the employer, worker, owner, manager, consumer or any person in control of the premises shall comply with any direction of the Public Health Commissioner in respect of social or physical distancing and hygiene.
4. In regards to outdoor public assemblies, the prohibition shall not have the effect of prohibiting assembly at bus stops, bus station, ports or airports exclusively for the purposes of travel or at medical facility for the purpose of seeking medical assistance subject to complying with any directions of the Public Health Commissioner in respect of social or physical distancing and hygiene.
5. Appropriate action shall be taken, against any person who fails to comply with this order, under the Public Health (Infectious Diseases) Regulations.
6. All the persons in Seychelles are hereby directed to refrain from engaging in or taking part in public assemblies or indoor public assemblies from the date of publication of this notice until further orders.

STATE LAND AND RIVER RESERVES (AMENDMENT) BILL, 2020*(Bill No. 15 of 2020)***OBJECTS AND REASONS**

This Bill seeks to amend the State Land and River Reserves Act, 1903, to permit the President to grant a concession or lease of State land to a foreign State or an international organisation or a specialized agency of the United Nations by free grant or by payment of nominal price or rent. The purpose of granting a concession or lease of such land is to facilitate the establishment or presence of more embassies, high commissions, international agencies or residence of heads of mission.

The object of the amendments is to give effect to legal obligations of the Republic of Seychelles under the Privileges and Immunities (Diplomatic, Consular and International Organisations) Act, 1980, and for the Republic of Seychelles to observe the doctrine of reciprocity under international law.

This Bill is linked to Seychelles foreign policy on promoting bilateral cooperation and as such, where the doctrine of reciprocity is not feasible or cannot be applied, the President may grant a lease of State land to a foreign State or international organisation that is significantly contributing to the socio-economic development of Seychelles.

The Bill seeks to amend section 6 of the State Land and River Reserves Act. In section 6, the words “foreign associate” is inserted in subsections (1) and (2). The President will have power to grant State land to a foreign State or an international organisation by free grant by a concession or lease on payment of a nominal price or rent. All such grants or leases will be conditional on the land being used for diplomatic purposes.

The Bill also seeks to define the concept of ‘foreign associate’ for the purposes of these amendments.

AN ACT to provide for provisions to permit the President to grant a concession or lease of State land to a foreign State or an international organisation by free grant or by payment of nominal price or rent and for matters incidental thereto.

ENACTED by the President and the National Assembly.

**PART I
PRELIMINARY**

1. This Act may be cited as the State Land and Reserves (Amendment) Act, 2020. Short title

2. The State Land and Reserves Act is amended as follows —

- (a) in section 2 by inserting in the proper alphabetical order the following definitions —

““foreign associate” shall be construed as meaning a foreign State, an international organisation or a specialized agency;

“specialized agency” means specialize agency as defined under the Privileges and Immunities (Diplomatic Consular and International Organisations) Act, Cap 228.”

- (b) in section 6 —

(i) by inserting in subsection (1) immediately after the words “or for purposes of public utility” the words “or for official or private premises of a foreign associate”;

(ii) by inserting in subsection (2) immediately after the words “or for purposes of public utility,” the words “or for official or private premises of a foreign associate,”.
