#### Oninion

We have audited the accompanying financial statements of "Al Salam Bank Seychelles Limited" set out on pages 7 to 34, which comprise the statement of financial position as at Occember 31, 2019, the income statement, statement of profit or loss and other comprehensive income, statement of changes in equity and statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements of the Bank give a true and fair view of the financial position of the Bank as at December 31, 2019 and of its financial performance and its cash flows for the year then ended in accordance with the, financial reporting provisions of IFRS's; the Companies Act 1972; the Financial Institutions Act 2004, as amended and Regulations and Directives of the Central Bank of Seychelles.

#### Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Bank in accordance with the International Ethics Standards Board for Accountants' Code of Ethics for Professional Accountants (IESBA Code) together with the ethical requirements that are relevant to our audit of the financial statements in Seychelles. We have fulfilled our other ethical responsibilities in accordance with these requirements and the IESBA Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

#### Emphasis of matter - Events after the reporting period -

We draw your attention to note 32 of the financial statements on concern considerations and concur with the directors of the Banks's ability to continue as a going concern.

#### Key audit matters

Key audit matters are those matters that, in our professional judgement, were of most significance in the audit of our financial statements of the current period. These matters were addressed in the context of our audit of the financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. For each matter below, our description of how our audit addressed the matter is provided in that context.

We have fulfilled the responsibilities described in the Auditor's responsibilities for the studit of the financial statements section of our report, including in relation to these matters. Accordingly, our audit included the performance of procedures designed to respond to our assessment of the risks of material misstatement of the financial statements. The results of our audit procedures, including the procedures performed to address the matters below, provide the basis for our audit opinion on the accompanying financial statements.

#### > Impairment allowance for Financial assets based on IFRS 9:

Our audit considered impairment allowance for financial assets as a key audit matter. The materiality of the reported amounts for financial assets (and impairment allowance thereof), the subjectivity associated with Management's impairment estimation underpinned our basis for considering it as a key audit matter.

The estimation of impairment allowance for financial assets involved complex manual calculations. Significant estimates and assumptions used by the Management in such calculations are disclosed in Note 4.

#### Key audit matters (cont...)

For assess the reasonableness of the impairment allowance, our audit procedures (among others) were designed to obtain sufficient and appropriate audit evidences, included the following:

- We evaluated design effectiveness of controls over estimation of impairment of financial assets, which included assessing the level of oversight, review and approval of impairment policies by the Board Audit Committee and Management.
- We test-checked the underlying calculations and data
- We assessed the completeness of the underlying information in financial assets used in the impairment calculations by agreeing details to the Bank's source documents and information in information technology system(IT).
- We also considered reasonableness of macro-economic and other factors used by management in their
  judgemental overlays for various types of financial assets, by comparing them with publicly available
  data and information sources.
- We obtained an understanding and checked the Branch's business model assessment and the test on the contractual cash flows, which give uses to eash flows that are solely payments of principal and interest [SPPI test] performed by the Branch's Consultant.
- We performed procedures to ensure the competence, objectivity and independence of the Branch's Consultant.
- We assessed the adequacy of the related financial statement disclosures as set out in Note 7.

#### IT systems and controls over financial icporting

The Bank's key financial accounting and reporting processes are highly dependent on the automated controls over the Bank's information systems. As such that there exist a risk that gaps in the IT control environment, including automated accounting procedures. IT dependent manual controls could result in the financial accounting and reporting records being materially misstated. The IT systems and controls, as they impact the financial accounting and reporting of transactions; is a key audit matter and our audit approach could significantly differ depending on the effective operation of the Bank's IT controls.

We performed the following procedures, among others.

- Understanding and evaluation of design effectiveness of key controls implemented by Management over generation of multiple system reports and collation of required information underpinning the significant amounts in the financial statements.
- Understanding the entity level control environment over 1T redundancy process.
- Examining Management's reconciliations between source systems and the general ledgers through to the spreadsheet workings.
- Test-checking;
  - source data with those of the related systems,
  - calculations to ensure accuracy of system parameters, and
  - process level maker checker mechanism in the system

#### Seychelles Pension Fund (Benefits) (Amendment) Regulations, 2020

In exercise of the powers conferred by section 68 of the Seychelles Pension Fund Act, 2005, the Minister responsible for Finance makes the following regulations —

1. These regulations may be cited as the Seychelles Pension Fund (Benefits) (Amendment) Regulations, 2020.

**2.** The Seychelles Pension Fund (Benefits) Regulations, 2005 are amended as follows —

Amendment of S.I. 46 of 2005 as last amended S.I. 92 of 2018

- (a) in regulation 2(1) by inserting after the definition of "prescribed retirement age" the following definition
  - " "retirement from work" means retirement from the normal or habitual level of occupational activity which the person carried on prior to the person's retirement.";
- (b) in regulation 8 by inserting after subregulation 1(E) the following regulation
  - "(1F) Where the retirement pension payable to a member under these regulations is less than SCR 1000, the amount of retirement pension payable shall be
    - (a) fixed at SCR1000 from the 1<sup>st</sup> January, 2020 to 31<sup>st</sup> May, 2020 and the difference shall be

- subsidised with the funds charged on the Consolidated Fund; and
- (b) fixed at SCR3000 from the 1<sup>st</sup> June, 2020 to 31<sup>st</sup> December, 2020.";
- (c) by repealing regulation 11(3) and substituting therefor the following subregulation
  - "(3) A retirement pension shall be payable from the date of entitlement where the application is made within 1 year from the date a member becomes entitled or where the application is not made within 1 year, from the date of making of the application.";
- (d) by repealing regulation 24(2) and substituting therefor the following subregulation
  - "(2) An incapacity pension shall be payable from the date of entitlement where the application is made within 1 year from the date on which the applicant becomes entitled or where the application is not made within 1 year, from the date of making of the application.";
- (e) by repealing regulation 29 (3) and substituting therefor the following subregulation
  - "(3) A surviving spouse pension shall be payable from the date of entitlement where the application is made within 1 year from the date the applicant becomes entitled or where the application is not made within 1 year, from the date of making of the application.";

- (f) by repealing regulation 34 (3) and substituting the following subregulation
  - "(3) A children's pension shall be payable from the date of entitlement where the application is made within 1 year from the date the child becomes entitled or where the application is not made within 1 year from the date of making the application."

AN ACT to amend the Employment Act, Cap 69; to regulate the deferment of payment, and the reduction, of wages of a worker pending the termination of the Government programme for salary support to workers as a result of the Covid-19 pandemic; to restrict the lay-off or redundancy of Seychellois workers in certain circumstances; to suspend any notice given to a worker until after 1st July 2020; and for matters incidental thereto.

**ENACTED** by the President and the National Assembly.

Short title

1. This Act may be cited as the Employment (Amendment) Act, 2020.

Amendment of Cap 69 as last amended by Act 24 of 2016

- 2. The Employment Act is amended as follows
  - (a) by inserting after section 39 the following section —

Prohibition against deferment or reduction of wages

- **"39A.**(1) Notwithstanding anything to the contrary in this Act, an employer shall not, whether with the agreement of the worker or otherwise
  - (a) defer the payment of wages, whether partly or otherwise, of a worker; or
  - (b) reduce the wages of a worker;

without first initiating and complying with the negotiation procedure.

- (2) Part 1A of schedule 1 shall, *mutatis mutandis*, apply to negotiation procedure under this section.
- (3) Where consequent to the negotiation procedure, the competent officer determines
  - (a) that payment of the wages may be deferred or that the wages may be reduced, as the case may be, the employer shall be entitled to defer payment of, or reduce, the wages in

sections 48 and 51 in respect of a non-Seychellois worker, or a worker in respect of whom the employer has not received full salary support from the Government.

(4) Any negotiation procedure initiated or applied for prior to 20<sup>th</sup> March, 2020, shall remain valid.

- (4) In making a determination under this section the competent officer shall take into account all relevant matters and shall, notwithstanding any other time-limit set out in this Act or any other law, make a determination within a period of 14 days from the start of the negotiation procedure.
- (5) The competent officer shall allow a deferment of the payment of the wages or a reduction of the wages, as the case may be, on being satisfied that the consent on the part of the worker to the deferment or reduction was obtained without any threat, duress, fraud or mistake.
- (6) This section shall not apply to a worker in respect of whom the employer has not received full salary support from the Government without prejudice to the right of a worker to initiate a grievance procedure under Part III of Schedule 1.

- (7) This section shall lapse on termination of the Government programme for salary support to employees in the private sector as a result of the Covid-19 pandemic."
- (b) by inserting after subsection 51 the following section —

Restriction on lay-off and redundancy of a Seychellois worker

- **51A.** An employer shall not be allowed to temporarily lay off or make redundant a Seychellois worker, if the employer
  - (a) is employing a non-Seychellois worker in a similar post as the Seychellois worker; and
  - (b) has not initiated the negotiation procedure to temporarily lay-off or make redundant, as the case may be, the non-Seychellois worker.
- (c) by inserting after subsection 81(1) the following section —

Suspension of negotiation procedure

- **"81A.**(1) Notwithstanding any other provision to the contrary in this Act, where
  - (a) an employer initiates, during the period from 20<sup>th</sup> March 2020 to 30<sup>th</sup> June 2020, the negotiation procedure for —

- (i) the reduction, or deferment of payment, of wages of a worker;
- (ii) the temporary lay-off of a worker; or
- (iii) terminating the contract of employment of a worker on the ground of redundancy; and
- (b) the competent officer, prior to 1<sup>st</sup> July 2020 approves, as the case may be
  - (i) the reduction, or deferment of payment, of wages of a worker;
  - (ii) the temporary lay-off of a worker; or
  - (iii) the termination of the contract of employment of a worker on the ground of redundancy;

any notice given by an employer to a worker, on the basis of such approval shall not take effect prior to 1<sup>st</sup> July, 2020.

- (2) Section 39A and subsection (1) shall be deemed to have come into operation on 20<sup>th</sup> March, 2020.
- (3) Subsection (1) shall not apply to the negotiation procedure under
