1. Real Estate Developer

A Real Estate Developer is a person engaged in the development, marketing and selling of multi-purpose buildings or immovable property used for residential purposes any time dating back to 1 January, 2010. A Real Estate Developer who wishes to conduct valuation of immovable property shall make an application to the Minister in such manner as may be directed. In conducting valuation of immovable property, a Real Estate Developer may be subject to such terms, conditions or limitations that the Minister deems necessary.
