Application, by petition, for an order confirming appointment of testamentary executor pursuant to section 23(1) of the Curatelle Act 2021 - Applicant has no legal incapacity and is ready and willing to be confirmed executor. Deceased's estate comprises of moveable and immovable properties that need to be vested into the executor - Application is granted, and accordingly, this Court confirms the testamentary appointment of the Applicant Georgette Marie Leroy born Philoe of La Louise, Mahe, Seychelles testamentary executrix of the estate of the deceased, the late Marie Madeleine Philoe born Labiche who died testate on the 23rd May 2021.

ORDER**N BURIAN, MASTER**

- [1] This is an application, by petition, filed in Court by Georgette Marie Leroy born Philoe of La Louise, Mahe, Seychelles (hereinafter referred to as "the Applicant") for an order of this Court confirming her appointment as executrix to the estate of the late Marie Madeleine Philoe born Labiche. The Applicant has filed this application by virtue of section 23(1) of the Curatelle Act 2021 (hereinafter 'the Act'), which application is supported by an affidavit as well as other relevant documents required to be produced as stipulated in section 23(5) of the Act.
- [2] On account of the affidavit evidence in support of the application, and the documentary evidence tendered as supporting exhibits, this Court is satisfied, that as per the Certificate of Death pertaining to the Civil Status Register No 297 of 2021. C, Marie Madeleine Philoe born Labiche (hereinafter referred to as "the deceased") died on the 23rd day of May 2021 at Victoria, Mahe, Seychelles. The deceased's Certificate of Death is tendered as exhibit marked P1.
- [3] This Court is satisfied, that at the time of death, the deceased (hereinafter referred to as "the Testatrix") left behind a notarial Last Will and Testament (hereinafter referred to as "the Will") made on the 16th January 2019, before Notary Daniel Belle. A copy of the said Will is tendered as exhibit marked P2.
- [4] By the terms of the said Will, the Testatrix appoints the Applicant Georgette Marie Leroy born Philoe as the sole testamentary executrix of her estate under her Will.
- [5] This Court is satisfied, as to the proof of identity of the testamentary executrix so appointed under the Will, that she is not subject to any legal incapacity, that she is ready and willing to be so confirmed testamentary executor, and to perform the duties of an executor as laid down by law, particularly, under Article 1027 and 1028 of the Civil Code of Seychelles Act 2020.

[6] Therefore, in accordance with the terms of the said Will, this Court hereby confirms the testamentary appointment of the Applicant Georgette Marie Leroy born Philoe as the sole testamentary executrix of the estate of the deceased, the late Marie Madeleine Philoe born Labiche.

[7] In line with the provisions of section 23(8) (a) and (b) of the Act and upon payment of the prescribed fees to the Registry of the Supreme Court, I hereby direct as follows:

- (i) That a copy of the order of appointment of executor containing the extract is to be sent for registration at the Mortgage and Registration Office; and
- (ii) That a notice of the said appointment of executor shall be published in the Gazette as per the prescribed form of the Second Schedule of the Act.

 - (d) a representative of the Ministry responsible for Community Affairs nominated by the Minister, after consultation with the Minister responsible for Community Affairs;”
- (b) by repealing subregulation (2), and substituting therefore, the following subregulation —

“(2) The Minister may appoint 3 other persons to be members, who in the opinion of the Minister, have knowledge and experience likely to contribute to the successful direction of the affairs and operations of the Agency.”
